REPRESENTATIVE MATTERS

In a first-party breach of contract action brought by Plaintiff in the U.S. District Court for the Southern District of Florida, an international insurance carrier was granted a motion for summary judgment resulting in dismissal of Plaintiff's \$17M claim.

In an action for breach of insurance contract arising out of property damage allegedly caused by Hurricane Irma, a motion to dismiss was granted in favor of international insurance carrier upon finding Plaintiff failed to bring suit against the carrier within Florida's 5-year statute of limitation.
